## DACA

## **Deferred Action for Childhood Arrivals**

As of January 13, 2018 due to a federal court order, USCIS has resumed accepting requests to renew DACA. As a result, the DACA policy will operate on the terms in place before it was rescinded on September 5, 2017. **Individuals who were previously granted DACA may now request renewal.** NOTE: USCIS is not accepting requests from individuals who have never before been granted DACA. USCIS will not accept or approve Advance Parole requests from DACA recipients.

On September 5, 2017, it was announced that the DACA (Deferred Action for Childhood Arrivals) program that was created under President Barack Obama would be terminated pending a six-month delay to allow Congress to take action.

In a legal memorandum issued September 5, 2017, Jacob Knapp, Acting General Counsel for the California Community College Chancellor's Office, stressed that:

The 'unwinding' of DACA does not impact a student's ability to attend our colleges, qualify for an exemption from nonresident tuition fees under AB540, or to apply for financial aid under the provisions of the California Dream Act. AB540 and the California Dream Act are state programs that are entirely separate and distinct from DACA and the federal enforcement of immigration laws.

### TOP 6 THINGS TO KNOW ABOUT THE CURRENT STATUS OF DACA



Your DACA is valid until its expiration date.



As of January 13, 2018, the DACA policy will operate on the terms in place before it was rescinded on September 5, 2017. As a result, USCIS will continue accepting DACA renewal applications.



Advance parole to travel is no longer available.



DACA status DOES NOT impact your college attendance or state financial aid eligibility.



#### CA affords eligibility for driving privileges to all residents, regardless of immigration status through AB 60.

## **PAYING FOR COLLEGE**

Effective January 1, 2018, Senate Bill 68 expanded qualifications for AB 540 and AB 2000 that allow undocumented students to pay in-state tuition at public universities.

### **REQUIREMENTS:**

- Must have attended a California high school for three or more years (do NOT have to be consecutive). Expansion now includes attendance in California community colleges, adult school or secondary school established by Department of Corrections & Rehabilitation.
- Or attained credits from a California high school equivalent to three or more years of full-time high school coursework and attended a combination of elementary, middle and/or high schools in California for a total of three or more years (AB 2000).
- Graduated from a California high school with a high school diploma or an equivalent GED. Expansion includes completion of Associate Degree from a California Community College and/or fulfillment of minimum CSU/UC transfer requirements.
- Must register or be currently enrolled in an institution of higher education (community college, CSU or UC).
- Must file the AB 540 Amended California Non-Resident Tuition Exemption Request Form at the selected institution of attendance & provide supporting documentation.

## Thanks to SB 150, high school students enrolled in college classes pay in-state tuition.

SB 150 allows undocumented high school students enrolled in college classes to pay resident fees. Students must be enrolled in 11 units or less and complete the California Residency Reclassification Request form found at www.contracosta.edu/dreamers









The California DREAM Act is a state law that allows undocumented students who qualify to receive financial aid from the state and our institution.

### **REQUIREMENTS:**

- Qualify for AB 540
- Be undocumented, have DACA status or have U-visa (T-visa holders apply for FAFSA)
- Successfully submit a Non-SSN GPA Verification to CA Student Aid Commission (CSAC) (it's recommended to mail this form to CSAC)
- Male students 18 years or older must register with Selective Service
- Must be enrolled in college at least half time (6 units or more)
- Must submit tax information or estimates if not yet filed
- Application to CA Dream Act and GPA verification must be submitted to be eligible for Cal Grants A, B & C
- Apply by March 2 (same deadline as FAFSA)

### Have no Fear!

## Any information that an undocumented student shares with a college or university is protected by FERPA.

It is important for students to know that advisors, financial aid counselors, and other college support staff are not required to report undocumented students to the US Citizenship and Immigration Services (USCIS). The Family Educational Rights and Privacy Act (FERPA) is a federal law that protects the privacy of student education records.

## Even if you don't qualify for AB 540... everyone can apply for scholarships!

Many scholarships are open to undocumented students. Scholarship funds help students pay for their higher education expenses when federal and state financial assistance is not available or enough. Unlike loans, scholarship funds do not have to be paid back!

## **KNOW YOUR RIGHTS**

Everyone—both documented and undocumented persons has rights in this country. Refer to the red card to exercise your right to remain silent in case you are stopped or questioned. Visit **www.ilrc.org/red-cards** 

You have constitutional rights:

**DO NOT OPEN THE DOOR** if an immigration agent is knocking on the door.

**DO NOT ANSWER ANY QUESTIONS** from an immigration agent if they try to talk to you. You have the right to remain silent.

**DO NOT SIGN ANYTHING** without first speaking to a lawyer. You have the right to speak with a lawyer.

**GIVE THIS CARD TO THE AGENT.** If you are inside of your home, show the card through the window or slide it under the door.

I do not wish to speak with you, answer your questions, or sign or hand you any documents based on my 5th Amendment rights under the United States Constitution.

I do not give you permission to enter my home based on my 4th Amendment rights under the United States Constitution unless you have a warrant to enter, signed by a judge or magistrate with my name on it that you slide under the door.

I do not give you permission to search any of my belongings based on my 4th Amendment rights.

I choose to exercise my constitutional rights.
