

#### **VACANCIES ON THE GOVERNING BOARD**

Vacancies on the Governing Board may be caused by any of the events specified in Government Code Section 1770 or any applicable provision in the Elections Code, or by a failure to elect. Resignations from the Governing Board shall be governed by Education Code Section 5090.

Within 60 days of a vacancy or the filing of a deferred resignation, the Governing Board shall either order an election or make a provisional appointment to fill the vacancy.

#### Election

If an election is ordered, it shall be held on the next regular election date not less than 130 days after the occurrence of the vacancy.

#### **Provisional Appointment**

If a provisional appointment is made, it shall be subject to the conditions in Education Code Section 5091.

- 1. The person appointed to the position shall hold office only until the next regularly scheduled election for District Governing Board members, when the election shall be held to fill the vacancy for the remainder of the unexpired term.
- 2. The provisional appointment will be made by a majority, public vote of the Governing Board members at a public meeting.

Education Code Sections 5090 et seq. Government Code Section 1770

#### **VACANCIES ON THE GOVERNING BOARD**

Whenever a vacancy occurs, the Governing Board shall within 60 days of the vacancy either order an election or make a provisional appointment to fill the vacancy. Should a vacancy occur following the resignation of a Governing Board member, he or she may not defer the effective date of his or her resignation for more than 60 days after official notification is received.

When an election is ordered to fill the vacancy, it shall be held on the next established election date provided pursuant to Chapter 1 (commencing with Section 1000) of Division 1 of the Elections Code not less than 130 days after the order of the election.

Should the Governing Board decide to fill the vacancy by making a provisional appointment, the following steps shall be taken.

#### Announcement of the Vacancy

Upon the Governing Board's decision to fill a Board vacancy by provisional appointment instead of an election, the Chancellor shall assure there is ample publicity and information for prospective candidates. Publicity shall include posting in three public places in the District and publication in a newspaper of general circulation. The posted notice of vacancy shall include directions to complete the provisional appointment applications or nominations of legally qualified candidates. Persons applying or nominated must meet the qualifications required by law for members of the Governing Board.

Persons applying for provisional appointment to the Governing Board shall receive a letter from the Chancellor containing information about the District and the Governing Board including the Governing Board Provisional Appointment Application Form (Exhibit A) which may include supplemental questions, to be completed and returned by a specific date.

#### Review of Applications and Selection of the Provisional Appointment

In a public session, Governing Board members will review and discuss all provisional appointment applications to determine applicants to be interviewed. Interviews and final selection of the provisional appointment shall be made by a majority vote of the Governing Board members at a public meeting called for that purpose.

#### Announcement of the Provisional Appointment Decision

When the provisional appointment is made, the Governing Board shall, within 10 days of the provisional appointment, post notices of both the actual vacancy or the filing of a deferred resignation and the provisional appointment in three public places in the District. A notice of the appointment shall be published in a newspaper of general circulation. The notice shall state the fact of the vacancy or resignation and the date of the occurrence of the vacancy or the date of the filing of, and the effective date of, the vacancy.

It shall also contain the full name of the provisional appointee to the Board, the date of appointment, and a statement that unless a petition calling for a special election, containing a sufficient number of signatures, is filed in the office of the county superintendent of schools within 30 days of the date of the provisional appointment, it shall become an effective appointment.

In the event the Governing Board fails to make a provisional appointment or order an election within the prescribed 60-day period, the county superintendent of schools shall order an election to fill the vacancy.

A provisional appointment confers all powers and duties of a Governing Board member upon the appointee immediately following his/her appointment. A person appointed to fill a vacancy shall hold office only until the next regularly scheduled election for Governing Board members. An election shall be held to fill the vacancy for the remainder of the unexpired term. A person elected at an election to fill the vacancy shall hold office for the remainder of the term in which the vacancy occurs or will occur.

#### OPEN PUBLIC SESSION AND PLEDGE OF ALLEGIANCE TO THE U.S. FLAG

Board President Vicki Gordon opened the public session at 9:01 a.m. Ms. Gordon then called on Mr. Márquez to lead the Pledge of Allegiance to the U.S. flag.

#### DISCUSSION TO DETERMINE PROCESS TO FILL BOARD VACANCY FOR WARD IV

Ms. Gordon said this special meeting was held to discuss whether a provisional appointment should be made or a special election held for the Ward IV vacancy. Ms. Gordon, Mr. Enholm, Mr. Farley and Mr. Márquez all agreed that a provisional appointment should be made.

The Board emphasized the importance of having a good process. Ms. Gordon directed human resources to lead this effort, and emphasized all applications should be screened to ensure the applicant lives within Ward IV and is a registered voter. The Board also agreed that it would review and discuss all applications at a special meeting, following by a second special meeting to interview three finalists. Ms. Gordon told the Board to review their calendars for late November and early December as the dates for these special meetings would be proposed soon.

Executive Vice Chancellor, Administrative Services Eugene Huff questioned whether the Board wanted to add further questions to the supplemental questionnaire continaed in the application found in Administrative Procedure 1021.01, <u>Vacancies on the Governing Board</u>. The Board said it did not want any other questions added to the provisional appointment application form. Mr. Huff said human resources would place the application packet on the website by October 25, 2016, with a closing date of November 15, 2016. Mr. Márquez commended Ms. Gordon for her leadership throughout the meeting.

#### PUBLIC COMMENT

Ray Sloan, Martinez community member and Alexander Pandell, Danville community member, spoke regarding the provisional appointment process.

#### **ADJOURNMENT**

There being no further business to come before the Governing Board, Ms. Gordon adjourned the meeting at 9:48 p.m. The next regular meeting of the Governing Board will be held at the George R. Gordon Education Center on Wednesday, November 9, 2016, at 4:00 p.m.

#### Standard IV: Leadership and Governance

The institution recognizes and uses the contributions of leadership throughout the organization for promoting student success, sustaining academic quality, integrity, fiscal stability, and continuous improvement of the institution. Governance roles are defined in policy and are designed to facilitate decisions that support student learning programs and services and improve institutional effectiveness, while acknowledging the designated responsibilities of the governing board and the chief executive officer. Through established governance structures, processes, and practices, the governing board, administrators, faculty, staff, and students work together for the good of the institution. In multi-college districts or systems, the roles within the district/system are clearly delineated. The multi-college district or system has policies for allocation of resources to adequately support and sustain the colleges.

#### A. Decision-Making Roles and Processes

- 1. Institutional leaders create and encourage innovation leading to institutional excellence. They support administrators, faculty, staff, and students, no matter what their official titles, in taking initiative for improving the practices, programs, and services in which they are involved. When ideas for improvement have policy or significant institution-wide implications, systematic participative processes are used to assure effective planning and implementation.
- 2. The institution establishes and implements policy and procedures authorizing administrator, faculty, and staff participation in decision-making processes. The policy makes provisions for student participation and consideration of student views in those matters in which students have a direct and reasonable interest. Policy specifies the manner in which individuals bring forward ideas and work together on appropriate policy, planning, and special-purpose committees.
- Administrators and faculty, through policy and procedures, have a substantive and clearly defined role in institutional governance and exercise a substantial voice in institutional policies, planning, and budget that relate to their areas of responsibility and expertise.
- 4. Faculty and academic administrators, through policy and procedures, and through well-defined structures, have responsibility for recommendations about curriculum and student learning programs and services.
- 5. Through its system of board and institutional governance, the institution ensures the appropriate consideration of relevant perspectives; decision-making aligned with expertise and responsibility; and timely action on institutional plans, policies, curricular change, and other key considerations.
- 6. The processes for decision-making and the resulting decisions are documented and widely communicated across the institution.
- 7. Leadership roles and the institution's governance and decision-making policies, procedures, and processes are regularly evaluated to assure their integrity and effectiveness. The institution widely communicates the results of these evaluations and uses them as the basis for improvement.

#### **B.** Chief Executive Officer

- 1. The institutional chief executive officer (CEO) has primary responsibility for the quality of the institution. The CEO provides effective leadership in planning, organizing, budgeting, selecting and developing personnel, and assessing institutional effectiveness.
- 2. The CEO plans, oversees, and evaluates an administrative structure organized and staffed to reflect the institution's purposes, size, and complexity. The CEO delegates authority to administrators and others consistent with their responsibilities, as appropriate.
- 3. Through established policies and procedures, the CEO guides institutional improvement of the teaching and learning environment by:
  - establishing a collegial process that sets values, goals, and priorities;
  - ensuring the college sets institutional performance standards for student achievement;
  - ensuring that evaluation and planning rely on high quality research and analysis of external and internal conditions;
  - ensuring that educational planning is integrated with resource planning and allocation to support student achievement and learning;
  - ensuring that the allocation of resources supports and improves learning and achievement; and
  - establishing procedures to evaluate overall institutional planning and implementation efforts to achieve the mission of the institution.
- 4. The CEO has the primary leadership role for accreditation, ensuring that the institution meets or exceeds Eligibility Requirements, Accreditation Standards, and Commission policies at all times. Faculty, staff, and administrative leaders of the institution also have responsibility for assuring compliance with accreditation requirements.
- 5. The CEO assures the implementation of statutes, regulations, and governing board policies and assures that institutional practices are consistent with institutional mission and policies, including effective control of budget and expenditures.
- 6. The CEO works and communicates effectively with the communities served by the institution.

#### C. Governing Board

- 1. The institution has a governing board that has authority over and responsibility for policies to assure the academic quality, integrity, and effectiveness of the student learning programs and services and the financial stability of the institution. (ER 7)
- 2. The governing board acts as a collective entity. Once the board reaches a decision, all board members act in support of the decision.
- 3. The governing board adheres to a clearly defined policy for selecting and evaluating the CEO of the college and/or the district/system.
- 4. The governing board is an independent, policy-making body that reflects the public interest in the institution's educational quality. It advocates for and defends the institution and protects it from undue influence or political pressure. (ER 7)
- 5. The governing board establishes policies consistent with the college/district/sys-tem mission to ensure the quality, integrity, and improvement of student learning programs and services and the resources necessary to support them. The governing board has ultimate responsibility for educational quality, legal matters, and financial integrity and stability.
- 6. The institution or the governing board publishes the board bylaws and policies specifying the board's size, duties, responsibilities, structure, and operating procedures.
- 7. The governing board acts in a manner consistent with its policies and bylaws. The board regularly assesses its policies and bylaws for their effectiveness in fulfilling the college/district/system mission and revises them as necessary.
- 8. To ensure the institution is accomplishing its goals for student success, the governing board regularly reviews key indicators of student learning and achievement and institutional plans for improving academic quality.
- 9. The governing board has an ongoing training program for board development, including new member orientation. It has a mechanism for providing for continuity of board membership and staggered terms of office.
- 10. Board policies and/or bylaws clearly establish a process for board evaluation. The evaluation assesses the board's effectiveness in promoting and sustaining academic quality and institutional effectiveness. The governing board regularly evaluates its practices and performance, including full participation in board training, and makes public the results. The results are used to improve board performance, academic quality, and institutional effectiveness.
- 11. The governing board upholds a code of ethics and conflict of interest policy, and individual board members adhere to the code. The board has a clearly defined policy for dealing with behavior that violates its code and implements it when necessary. A majority of the board members have no employment, family, ownership, or other

personal financial interest in the institution. Board member interests are disclosed and do not interfere with the impartiality of governing body members or outweigh the greater duty to secure and ensure the academic and fiscal integrity of the institution. (ER 7)

- 12. The governing board delegates full responsibility and authority to the CEO to implement and administer board policies without board interference and holds the CEO accountable for the operation of the district/system or college, respectively.
- 13. The governing board is informed about the Eligibility Requirements, the Accreditation Standards, Commission policies, accreditation processes, and the college's accredited status, and supports through policy the college's efforts to improve and excel. The board participates in evaluation of governing board roles and functions in the accreditation process.

#### D. Multi-College Districts or Systems

- In multi-college districts or systems, the district/system CEO provides leadership in setting and communicating expectations of educational excellence and integrity throughout the district/system and assures support for the effective operation of the colleges. Working with the colleges, the district/system CEO establishes clearly defined roles, authority and responsibility between the colleges and the district/system.
- 2. The district/system CEO clearly delineates, documents, and communicates the operational responsibilities and functions of the district/system from those of the colleges and consistently adheres to this delineation in practice. The district/system CEO ensures that the colleges receive effective and adequate district/system provided services to support the colleges in achieving their missions. Where a district/system has responsibility for resources, allocation of resources, and planning, it is evaluated against the Standards, and its performance is reflected in the accredited status of the institution.
- 3. The district/system has a policy for allocation and reallocation of resources that are adequate to support the effective operations and sustainability of the colleges and district/system. The district/system CEO ensures effective control of expenditures.
- 4. The CEO of the district or system delegates full responsibility and authority to the CEOs of the colleges to implement and administer delegated district/system policies without interference and holds college CEO's accountable for the operation of the colleges.
- 5. District/system planning and evaluation are integrated with college planning and evaluation to improve student learning and achievement and institutional effectiveness.
- 6. Communication between colleges and districts/systems ensures effective operations of the colleges and should be timely, accurate, and complete in order for the colleges to make decisions effectively.
- 7. The district/system CEO regularly evaluates district/system and college role delineations, governance and decision-making processes to assure their integrity and effectiveness in assisting the colleges in meeting educational goals for student achievement and learning. The district/system widely communicates the results of these evaluations and uses them as the basis for improvement.

My name is Jerome Pandell, and I respectfully submit this application to join your ranks as the new trustee from Ward IV.

The passing of Trustee John Nejedly represented a tragic loss for the Contra Costa Community College District, both in terms of perspective on important issues and institutional memory. I apply for this post knowing nobody can easily fill his shoes. However, I believe my experience as a construction litigation attorney and my community service to students and public education institutions at both the K-12 level and in higher education match some strengths for which Trustee Nejedly became known. I also bring the perspective of someone not far removed from my own college experience, a unique voice at a time when students face challenges related to accessibility and affordability of higher education.

As an attorney at Pandell Law Firm, my practice focuses on representing design professionals in civil litigation matters. Some of the disputes I handle (and successfully resolve, usually through mediation) involve publicly funded projects. 

## INTERVIEW APPLICANTS TO FILL BOARD VACANCY FOR WARD IV AND SELECITON OF TWO FINALISTS

Ms. Gordon said five applicants would be interviewed. They would each have 25 minutes to answer seven screening interview questions. The five applicants interviewed were in the following order: Frank Quattro; April Treece; Gary Walker-Roberts; Jerome Pandell; and Carl Nichols.

Ms. Gordon noted that Mr. Nichols turned in additional paperwork supporting his application. Ms. Gordon also said two other applications were received for this provisional appointment, but the decision was made not to interview those two applicants. One application was received after the deadline and the other application contained materials from someone who did not reside within Ward IV.

Mr. Farley said Mr. Walker-Roberts and Ms. Treece were tied in his rankings. Following Board policy, a coin was again tossed and Mr. Walker-Roberts won the toss, placing him as the first choice for Mr. Farley, followed by Ms. Treece as second choice..

Mr. Márquez said Mr. Walker-Roberts was his first choice and Mr. Nichols was his second choice. Ms. Gordon also selected Mr. Walker-Roberts as her first choice and Mr. Nichols as her second choice.

After all rankings had been made, Mr. Farley said he wanted to make a motion for the provisional appointment nomination, adding there was no need to hold final interviews, since one applicant received most first place rankings. Mr. Farley's motion was seconded by Mr. Márquez and with two aye votes from Ms. Gordon and Mr. Enholm, the Board, with four aye votes, agreed to announce the provisional appointee without conducting final interviews.
